Schools and Users

- Provide staff involved in the admissions process with secure, on-line access to track progress of their applicants and view application details in real-time.
- Ability for faculty to review candidates online.
- Increase exposure to a larger applicant pool, including applicants from minority populations.
- Helps direct students to open seats in participating programs.
- No cost for schools or programs.
- Streamline the admissions process and reduce administrative tasks by refocusing of current resources on higher level interaction with applicants.
- Schools/programs receive verified and standardized applicant information for easier review (letters of recommendation, test scores, international transcripts).

What is the Nursing Centralized Application Service (NursingCAS)?

Nursing's Centralized Application Service (NursingCAS) allows applicants to use a single online application and one set of materials to apply to multiple nursing programs at participating schools.

How It Works:

- 1. Research Programs of Interest
- 2. Apply to Selected Programs
- 3. Submit Supporting Materials
 - Transcripts
 - References
 - Personal Statements
 - Supporting Documents (example: resume)
 - Licensure and Certification Data
 - Education History
 - Professional Experience

The application is submitted through the centralized application service designed to make available electronically applicant data to staff involved in the admissions process.

Applicants pay a nominal fee to use the service:

- A convenient and efficient process to apply to multiple schools using a single Web-based application.
- A comprehensive online checklist and instructions to help applicants easily navigate through the application.
- Eliminate the need and costs associated with duplicate application data, letters of reference, and transcripts for those applying to more than one school.
- Provide applicants with real-time status to check the receipt of their applications, transcripts, and letters of reference.
- A single online resource to research and compare different schools using comparative data.
- A seamless and integrated letters of reference process (electronic).
- Robust application validation rules that reduce unintended applicant errors and omissions.
- Dedicated and knowledgeable NursingCAS support staff available throughout the application cycle.

Benefits to the Profession

- Compile accurate statistics on the profession: Number of applicants, designations, feeder schools, matriculation and applicant pool profile (ethnicity, demographic, geographic, and economic).
